

The ACC, BCSOA, RVSOA and Shore chapters have agreed to sponsor 4 interpretation meetings jointly rather than each chapter running its own interpretation meeting. This will allow flexibility for referees to join remotely on the most convenient date rather than the typical travel to an in-person meeting on a single date. Since these are jointly sponsored, no chapter business will be conducted.

Meeting dates are listed below – all officials must attend one interpretation meeting each year to remain eligible to officiate games, although you are welcome to join more than one. Attendance maximum is 500 per meeting so we do not expect to reach capacity. All meetings will begin at 7:00 sharp and last approximately one hour, depending upon the number of questions. The meeting will open for referees to sign in starting at 6:30 PM. If you have not signed in by 7:00 PM, you will not be admitted from the waiting room into the meeting – you will need to register and attend a later meeting.

Here are the step by step instructions to register for and attend a meeting:

1. We will use Zoom for these online meetings. If you do not currently have the Zoom app downloaded, please do so in advance of the meeting date.
2. We will only allow attendance where you can see and hear the presentation on a tablet or larger device so be prepared.
3. Decide which date(s) you can attend on time by 7:00 pm – you will be able to sign in to the meeting after 6:30 PM.
4. For the date you wish to attend, select the link below to register for that meeting.
5. Once you click on the link for the meeting for a particular date, you will need to register for the meeting with your first name, last name, email address and confirmation of email address. There also is a question regarding the chapter in which you are a member, which must be answered. This is how the chapters will track attendance.
6. After registering, you will receive a confirmation email containing information about joining the meeting. If you entered your email incorrectly, you will not receive the email.
7. On the meeting date after 6:30 PM, click the link from the email received or copy and paste into your browser. If you downloaded the Zoom app to your device, you will be prompted to open the Zoom app.
8. Follow instructions online to join the meeting.
9. You will be placed in a waiting room – the host will then let you into the meeting provided it is not yet 7:00 and the meeting has not started.
10. If you miss the meeting, register for another meeting.
11. Your video feed will not be activated and your microphone will be muted unless activated by the host.
12. Make sure your audio is of a sufficient level to hear the presenter.
13. Questions can be asked in the chat function usually at the bottom of your screen when you move your mouse/cursor over the presentation. The chat will be monitored by a chapter official to address any questions. Only questions related to the new rules/other changes will be answered; contact your chapter representatives for chapter related questions.
